### **Immunisation Programme Updates**

#### National Call and Recall for Children Missing MMR Doses

NHS England will be sending communications to parents/guardians of children aged 1 to under 6 years whose record shows they are missing one or both MMR doses, advising them to contact their child's general practice to book vaccination. This forms part of the GP contract requirement for practices to participate in a national vaccination campaign each year. Practices should check the child's vaccine status and vaccinate as appropriate. Contact with parents/guardians resulting from this MMR call/recall is also an opportunity to check the status of the child for any other vaccines they require and, if they are eligible, to also offer flu vaccination.

## Opportunistic MenACWY and HPV Vaccination in General Practice

As higher education students start a new academic year, young people may be advised by their institution to check they are up to date with these vaccinations and wish to be vaccinated. Administration of MenACWY and HPV vaccines are essential services and should be offered on an opportunistic basis, or if requested, to those eligible aged up to 25 years who have missed vaccination under the routine school-aged immunisation programme. The cessation of the MenACWY Freshers Programme in 2020/21 does not remove this requirement, as this was a distinct catch-up programme.

#### **Vaccination Records**

Practices are asked to ensure that vaccination records are added to the patient record when vaccines are administered and when new patients join the surgery.

The vaccination codes and administration dates need to be recorded accurately.

#### Increase in Cases of Diphtheria amongst Asylum Seekers and Refugees

The UK Health Security Agency (UKHSA) have confirmed that since February 2022, there have been five confirmed cases of diphtheria identified in asylum seekers in the UK with early reports that this situation is mirrored across several European countries. Many cases have presented with cutaneous lesions.

Clinicians are reminded that the two key diphtheria causing strains, *C. diphtheriae* and *C. ulcerans*, may present with cutaneous and/or respiratory presentations and can lead to severe disease in those who are not immunised or fully vaccinated. Healthcare staff involved with supporting new arrivals should consider investigating for suspected diphtheria in individuals presenting with cutaneous lesions and ensure careful use of PPE when assessing patients. It is important that all staff are fully immunised. Vaccination status should be assessed and any new arrivals with incomplete schedules should be caught-up as per the UK schedule. #### **Use of Vaccines Following Cold Chain Incidents**

Following manufacturer advice to confirm that vaccines are still stable and effective following a cold chain incident, practices are not obliged to inform patients that the affected vaccines are being used off-license and these can still be used under a PGD.

#### **CERVICAL**

Guide for Sample Takers and GP Admin Staff on How to Check Screening Eligibility and Next Test Due Dates on Open Exeter

The sample taker is responsible for making sure a person is eligible for cervical screening and due a test and should not routinely contact the laboratory or colposcopy for this information.

Please see the attached guide for sample takers and GP admin staff on how to check screening eligibility and next test due dates on Open Exeter.

#### **Cervical Sample Taker Training Requirements**

All training in cervical screening whether at foundation/introductory level or the three yearly update must be with an accredited provider. If you are in any doubt about accreditation status of the course you want to clarify this with the provider or contact the Screening and Immunisation Team.

Please note that the e-lfh online UPDATE course is an accredited update course for those that have completed and passed both their theory and practical elements following the introductory/foundation course only. It can be accessed at <a href="https://portal.e-lfh.org.uk/">https://portal.e-lfh.org.uk/</a>

All staff new to sample taking must undertake an accredited two-day foundation/introductory course before they can be issued with a trainee sample taker code and start taking supervised samples.

Trainee sample takers should take 20 acceptable cervical samples without direct supervision and no more than 25 up to the point of final assessment.
