Re: Advanced Care Planning-Personalised Approach-COVID-19 Pandemic:

Guide to End of Life Care symptom control when a person is dying from COVID19 care for General Practice Teams, RCGP and the Association for Palliative Medicine

You may have already seen the joint statement by the BMA, CQC, RCGP, Care Provider Alliance (published 20 March 2020) which highlights the importance of a personalised approach when putting advance care plans (ACPs) in place, for older people and those who are frail or have serious pre-existing medical conditions.

All the COVID-19 evidence shows that more people than usual will become ill and may deteriorate quickly. This makes it particularly important to ensure that individuals have ACPs in place as ACPs allow for individualised decisions about whether it is appropriate to consider managing deterioration in the existing care setting, rather than suggesting conveyance to hospital.

We are aware that this urgent work will require already over stretched, trained colleagues, to hold difficult and sensitive conversations, in order to create records of ACPs, which are accessible to all.

Many of you may have already started this work and for those who have not, please use the coming days to do as much of this work as possible.

We would also like to draw your attention to some relevant useful guidance:
